

RESOLUTION 19-1
Section 03-00167-04-JT

WHEREAS, Rochester Township will accept jurisdiction and maintenance of a portion of County Highway 37 (CH 37) known as Cardinal Hill Road (FAU 8074) that it is in Rochester Township from the southern limits of FAU 8074 that is under current jurisdiction of the Village of Rochester south to the connection with Triangle Road (TR 273B), a distance of 0.19 miles, in its entirety, in its present condition; and,

WHEREAS, Sangamon County will continue to maintain the above portion of Cardinal Hill Road until completion of the construction of the new Cardinal Hill Road known as Sangamon County Section 03-00167-04-FP per the Local Agency Agreement identified as Rochester Township Section 06-22000-01-JT and Sangamon County Section 03-00167-04-JT; and,

WHEREAS, The remaining portion of this section of Cardinal Hill Road (CH 37) from the intersection of Triangle Road (TR 273 B) south for a distance of 0.364 miles will be degraded and returned to the adjacent property owners per right-of-way negotiations as part of this project and will no longer serve as or meet the legal requirements of a County Highway because of the County Highway being relocated; and,


WHEREAS, The construction of the extension of Oak Hill Road (TR 273 & TR 273 A) from Triangle Road (TR 273 B) east to the new relocated Cardinal Hill Road (CH 37) as part of the project known as Sangamon County Section 03-00167-04-FP will become part of the Rochester Township road system.

NOW THEREFORE BE IT RESOLVED, by the County Board of Sangamon County, at its Regular Reconvened Adjourned September Session, assembled this 12th day of December, A.D. 2006, that the portion of County Highway 37 as described above is hereby approved to be deleted from the Sangamon County Highway System; and,

BE IT FURTHER RESOLVED, by the County Board of Sangamon County that the "Local Agency Agreement for Jurisdictional Transfer" between Sangamon County and Rochester Township, be approved; and,

BE IT FURTHER RESOLVED, by the County Board of Sangamon County that the Chairman of the County Board is hereby authorized and directed to sign said Agreement for Jurisdictional Transfer on behalf of Sangamon County.
