WHEREAS, the Zoning Board of Appeals has presented to the Sangamon County Board, Sangamon County, Illinois, its Findings of Fact and Recommendation that the Sangamon County Board **deny an amendment** to the Sangamon County Zoning Ordinance with respect to the following described property, to-wit:

**Lots Two (2), Three (3) and Four (4) of Block Four (4) Town of Clarksville, Now Berry.**

WHEREAS, the Petitioner, **Chris Manion**, has petitioned the Sangamon County Board for a rezoning from "R-1" Single Family Residence District to "RM-4" Manufactured Home District to allow for a manufactured home; and

WHEREAS, a public hearing was held at the Sangamon County Building on **October 20, 2011** after proper notice was posted on said property and given by news publication, as is required by said Ordinance, and all procedural and jurisdictional requirements of the Sangamon County Zoning Ordinance have been met; and

WHEREAS, the Sangamon County Zoning Board of Appeals has presented to the Sangamon County Board of Sangamon County its Findings of Fact and Recommendation that the Sangamon County Board **deny the rezoning**; and

WHEREAS, the Sangamon County Board does hereby adopt the recommendation of the Sangamon County Zoning Board of Appeals.

Recommend denial of the requested RM-4 zoning. In 2008, staff recommended approval of this request because there were unique circumstances in that the owner did not place a the new manufactured home in place of the old one within the six month time frame. At that time, it was considered a resonable amount of time and an acceptable request. However, the request was denied by the County Board and precedent was set for the subject parcels. It has been approximately three years since the original request and a spot of RM-4 zoning is not seen as appropriate since a single family residence could be placed on the vacant lot.

2. That the above-captioned petitioner(s) is the owner(s) and/or has a beneficial interest in, contract to purchase, or is the County Board Member representing the property commonly known as: **9596 Clarksville Road, Rochester, IL.** and more particularly described as:

- 8. The evidence adduced at the hearing **does not** support the proposition that the adoption of the proposed **rezoning** is in the public interest and is not solely in the interest of the petitioner(s).

IT IS, THEREFORE, the recommendation of the Sangamon County Zoning Board of Appeals to the County Board of Sangamon County that the requested **rezoning** be **denied**.
