MINUTES

SANGAMON COUNTY BOARD

MAY 10, 2011

The Sangamon County Board met in Reconvened Adjourned September Session on May 10, 2011 in the County Board Chambers. Chairman VanMeter called the meeting to order at 7:00 p.m. Mr. Moore gave the Invocation and Mr. Preckwinkle led the Board in the Pledge of Allegiance.

ROLL CALL

Chairman VanMeter asked the County Clerk to call the roll. There were 26 Present – 2 Absent. Mr. Fraase and Mr. Stephens were excused.

PROCLAMATIONS

Mr. Stumpf presented a Proclamation acknowledging Vintage Tech Recyclers and Angela Harris, Sangamon County Recycling Coordinator, for their work and continued efforts to promote and provide recycling opportunities. Angela Harris accepted the Proclamation and thanked the Board. She encouraged everyone to support recycling programs. With their support, they hope to broaden the various programs and recycling initiatives that residents of Sangamon County can enjoy.

Mr. Goleman asked Chief Deputy Sheriff Jack Campbell to present a Proclamation to retired Deputy Leah Boston in recognition of her accomplishments and dedication in serving the citizens of Sangamon County. Leah Boston accepted the Proclamation.

Chairman VanMeter presented a Proclamation to Doris Turner in recognition of her many important achievements for Sangamon County.
