SANGAMON COUNTY RESOLUTION AMENDING CHAPTERS 6.04, 5.28, 5.24, 5.20 AND 15.05
OF THE SANGAMON COUNTY CODE

WHEREAS, pursuant to 55 ILCS 5/5-25001 et seq. of the Illinois Revised Statues Sangamon County is authorized by State Law to set Public Health fees that are reasonable and just; and

WHEREAS, Fiscal Choice Consulting, LLC, was hired by Sangamon County in 2016 to conduct an updated cost study for SCDPH; and

WHEREAS, the Fiscal Choice Consulting cost study for SCDPH identified numerous services that were operating at deficits as a result of costs exceeding revenue generated by fees; and

WHEREAS, establishing fees in accordance with actual cost is a priority for the County because of property tax caps; and

WHEREAS, the Sangamon County Board of Health recommends the Sangamon County Board amend its fee schedule for Animal Control, Food, Private Sewage, Water Wells, and Building Code Enforcement services; and

WHEREAS, the Finance, and the Public Health and Zoning committees of the Sangamon County Board held public meetings to consider the Board of Health recommendations;

NOW, THEREFORE, BE IT RESOLVED, by the members of the County Board of Sangamon County, Illinois, in session this 11th day of July, 2017:

- I. Chapter 6.04 of the Sangamon County Code of Ordinances ANIMAL CONTROL is amended and adopted, effective immediately, as further described in Exhibit "A", a copy of which is attached hereto and made a part hereof.
- II. Chapter 5.28 of the Sangamon County Code of Ordinances PRIVATE SEWAGE DISPOSAL SYSTEMS is amended and adopted, effective immediately, as further described in Exhibit "B", a copy of which is attached hereto and made a part hereof.
- III. Chapter 5.24 of the Sangamon County Code of Ordinances WATER WELLS AND WATER SUPPLY is amended and adopted, effective immediately, as further described in Exhibit "C", a copy of which is attached hereto and made a part hereof.
- IV. Chapter 5.20 of the Sangamon County Code of Ordinances FOOD SERVICE ESTABLISHMENTS is amended and adopted, effective immediately, as further described in Exhibit "D", a copy of which is attached hereto and made a part hereof.
- V. Chapter 15.05 of the Sangamon County Code of Ordinances BUILDING



In addition to the foregoing holidays, the Presiding Judge may declare a court holiday when court facilities are otherwise closed for the observance of a holiday not listed above. These additional observances shall be limited to only those situations in which both court security is unavailable and all county government offices are closed.

In the event the court facilities in a county of the Seventh Judicial Circuit are to remain open on one or more of the holidays, the Chief Circuit Judge of this Circuit, or the Presiding Judge in the county in this Circuit in which that situation occurs, may disregard the listed holiday and declare the Court open on that day.


