WHEREAS, the Department of Child Advocacy Center wishes to apply for and accept an a grant from Department of Children and Family Services for the Child Advocacy Center program in the amount of approximately \$116,746.00; and

WHEREAS, this grant will allow Child Advocacy Center to provide child advocacy services; and

WHEREAS, as documented by the approval of this resolution, the Finance Committee has approved the Child Advocacy Center Department's request to apply for the Department of Children and Family Services grant and the committee recommends that the County Board approve the acceptance of this grant, if awarded by Department of Children and Family Services.

NOW, THEREFORE, BE IT RESOLVED that the Sangamon County Board, in session this 23rd day of June, 2020, approves the acceptance of the Department of Children and Family Services grant, which is detailed above, if the grant is awarded to the County by Department of Children and Family Services. 
